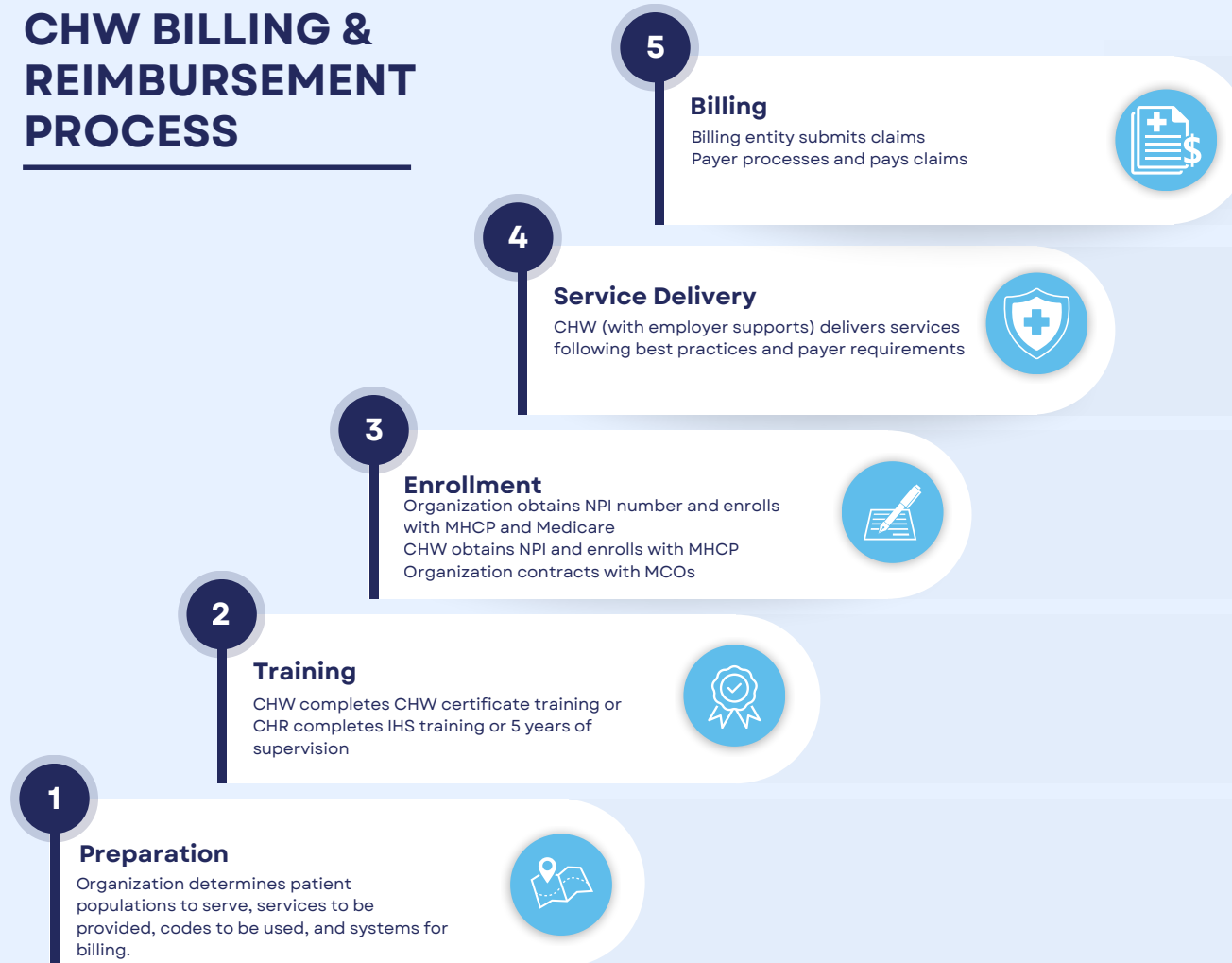

CHW BILLING & REIMBURSEMENT PROCESS



Organizational Uniqueness – Dental Health Organizations

What is unique about dental organizations and CHW billing?

- Already delivering dental health education services that meet current CHW health education code requirements
- Set-up for dental billing (EHR, clearinghouse, billing staff)
- Can negotiate higher reimbursement rates with payers
- Following data security policies and practices
- Experience enrolling providers with MN Health Care Programs (MHCP), and familiar with using MHCP provider manual
- Set of dental codes billable annually (next slide)
- Barriers:
 - Current Medical CHW Health Education codes (98960, 98961, 98962) cannot be submitted on dental claims forms (June 16, 2026: requested new dental specific CHW codes from DHS)
 - Not clear if providing ongoing dental services qualifies as billing provider for Community Health Integration (CHI) codes (G0019, G0022)

Organizational Uniqueness – Dental Health Organizations

What is unique about dental organizations and CHW billing?

- Per MN DHS, besides fluoride varnish D1206, these additional CDT codes can be billed to MHCP when a CHW is working under a dentist.
 - D1301 immunization counseling
 - D1310 nutritional counseling for control of dental disease
 - D1320 tobacco counseling for the control and prevention of dental disease
 - D1321 counseling for the control and prevention of adverse oral behavioral and systemic health effects associated with high-risk substance use
 - D1330 oral hygiene instruction
- Covered once per member per year.
- Billing for these codes and receiving payment indicates time and effort were provided in these counseling episodes.

Five Steps to CHW Billing: STEP ONE - Preparation

Think about:

1. What populations will be served by your CHW team?
 - a) What are the demographics of your patient populations? (Medicaid/MA, Medicare, dual eligibles)
 - b) Which payers offer MA coverage in the counties your organization serves? (see DHS map handout)
2. What CHW services will be provided and where?
 - a) Will your services be individual (1:1) or will you offer groups?
 - b) What encounter locations fit your populations served? (home visits, community locations, office, telehealth, mobile unit)

Five Steps to CHW Billing: STEP ONE - Preparation

Think about:

1. Which CPT codes will be used?
 - a) Dental Varnish (D1206)
 - b) Dental Counseling (D1301, D1310, D1320, D1321, D1330)
 - c) (TBD) New dental-specific CHW codes?
 - d) Health Education (98960, 98961, 98962, 98962 U9) (must use a medical claims form)
 - e) Community Health Integration (CHI) (G0019, G0022) (must use a medical claims form)
2. What systems will be used for billing?
 - a) EHR, clearinghouse (integrated with your EHR or stand alone?), payer portals, MNITS.

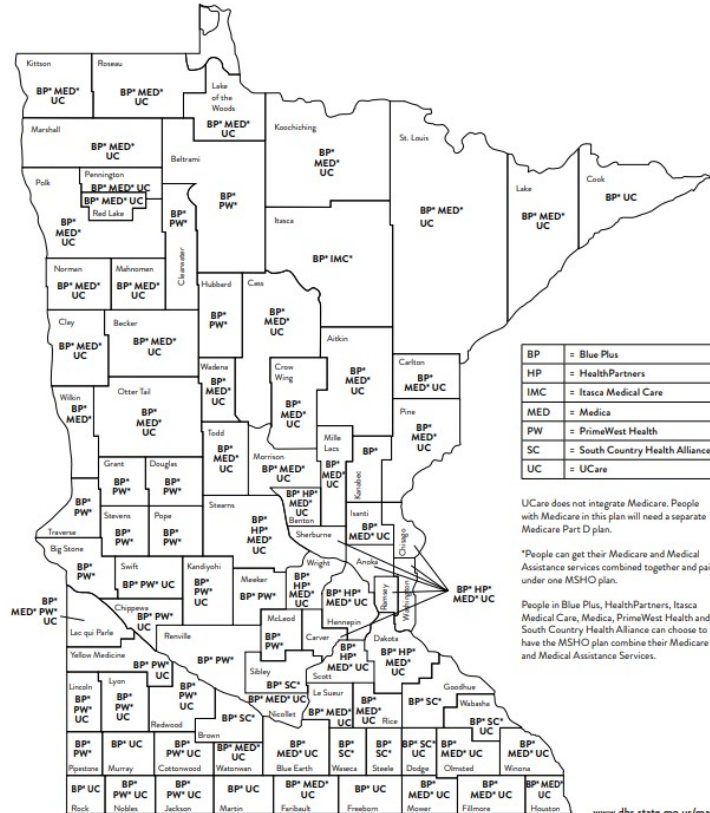

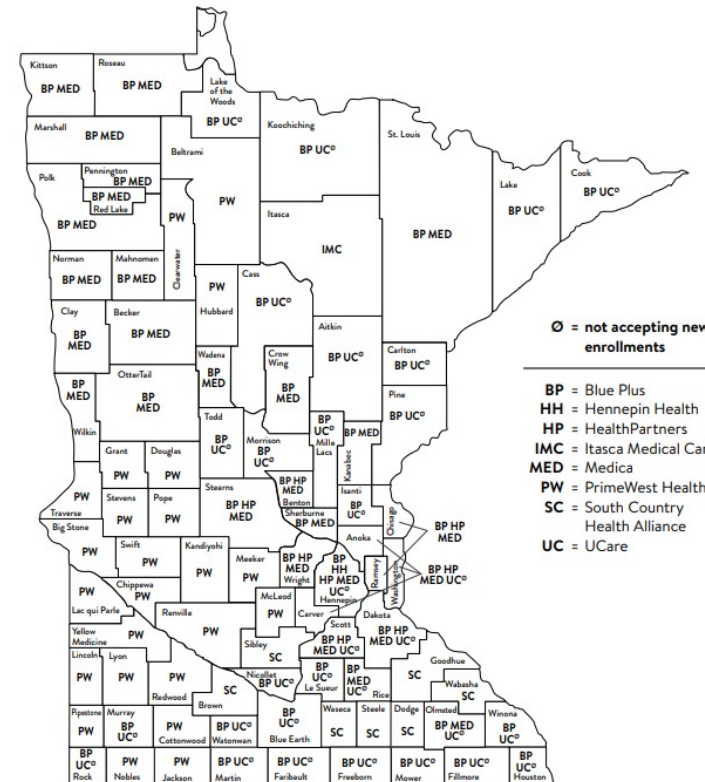

Cost Analysis Tool

The Cost Analysis Tool is a spreadsheet organized by tabs that allow the user to model their program details including:

- Service delivery & Billing Revenue (patient population(s), program mix, payor mix, service mix, reimbursement rates)
- Productivity (number of CHWs roles, percentage of time that is assumed to be billable, number of cases served)
- Program Costs (CHW salaries/benefits/technology, Clinical and Administrative oversight, general operating overhead)
- Other sources of income (grants, internal transfers, other programs (MNSure Navigation, etc))

Cost Analysis Tool Continued

The Cost Analysis Tool was created to allow users to “plug in” their unique CHW program details to:

- Calculate their team’s billable productivity
- Understand likely levels of revenue generated by claims reimbursement
- Estimate the direct and indirect costs associated with offering their CHW program; and
- Identify the need for additional income (grants, internal transfers, etc) to make the program operationally and financially sustainable.

Cost Analysis Tool – Scenario

CHW Organization:

- Serving 100 MA-eligible patients per year
 - 10 covered by “straight MA”
 - 90 covered by MCOs (reimbursing @ 200% base MA rate)
- Providing 1-on-1 Health Education services
 - Average of 2 hours per month, over 6 months (24 units per patient, per year)
 - Existing and new dental codes can be added to the tool
- Employing 2 full-time CHWs
 - Assuming CHWs earn \$23/hour + benefits and are billable 50% of their time

Five Steps to CHW Billing: STEP 2 - Training

Think about:

1. Will your CHWs be hired with their certificates already in hand or will they need to enroll in the Minnesota CHW Certificate Training? NOTE: If you work for a Tribal Health organization, Community Health Representatives (CHRs) can complete IHS training or 5 years of supervised experience.
2. Will your organization pay for the tuition?
3. What school will you send your CHWs to?
 - a) 16-17 credit certificate offered at five schools
 - b) Northwest Technical College, Minnesota West Community & Technical College, Normandale Community College, Anoka Technical College, St. Catherine University

Five Steps to CHW Billing: STEP 2 - Training

Think about: organizational training recommendations

1. HIPAA and FWA
2. Working with the Ordering Provider and clinical teams
3. Motivational Interviewing
4. Best practices and documentation
5. Fidelity to workflows
6. Condition-specific training (MCD Global Health Training <https://chwtraining.mcd.org>).

Five Steps to CHW Billing: STEP 3 - Enrollment

Think about: organizational provider enrollment

Your organization must be enrolled with MHCP to bill for CHW services, or partnering with another MHCP enrolled organization.

1. Organization obtains Type 2 NPI using NPPES ([National Plan and Provider Enumeration System \(https://nppes.cms.hhs.gov/\)](https://nppes.cms.hhs.gov/))
2. Enroll your organization with MHCP in the DHS the Minnesota Provider Screening and Enrollment Portal (MPSE). 3. If enrolling with Medicare, enroll your organization with using PECOS : [Medicare Provider Enrollment, Chain, and Ownership System](https://www.cms.gov/medicare/enrollment-renewal/providers-suppliers)

Five Steps to CHW Billing: STEP 3 - Enrollment

Think about: CHW provider enrollment with MHCP

1. Who will help the CHWs complete enrollment documents and apply for their Type 1 NPI? Does your organization already use the MPSE portal on MNITS?

1. CHWs obtains Type 1 NPI using NPES: [National Plan and Provider Enumeration System \(https://nppes.cms.hhs.gov/\)](https://nppes.cms.hhs.gov/)
2. 3. Complete the required DHS provider enrollment forms
 - a) DHS-4016 Individual Provider Enrollment Application
 - b) DHS-4138 FFS and MCO In-Network Provider Agreement
 - c) DHS-5308 Community Health Worker Provider Assurance Statement
 - d) DHS-6806 Telehealth Provider Assurance Statement (optional)

Five Steps to CHW Billing: STEP 3 - Enrollment

Think about: organizational enrollment with MCOs

1. AFTER you are fully enrolled with MHCP, and receive your Welcome Letter, you can start the contracting process with the MCOs.
2. Each MCO has specific contracting and credentialing requirements. Contact each MCO that you would like to be contracted with to inquire about how to start the process.

Five Steps to CHW Billing: STEP 4 - Service Delivery

Think about: documentation

1. How will you establish documentation procedures that include the required DHS data points? (see the [DHS CHW Provider Manual](#) for requirements)
2. Who will help create smart phrases, drop down menus, check boxes, etc to streamline documentation, save time, ensure consistency, and keep “free hand narrative” to a minimum?
3. How will you pay CHW staff for non-billable time such as documentation?
4. How will you provide training on following established documentation practices to avoid pitfalls of excessive narrative and stay on track to document mainly the required documentation points?

Five Steps to CHW Billing: STEP 4 - Service Delivery

Think about: service delivery details

1. What services you are providing and which codes you are billing?
 - a) CHW: 98960, 98961, 98962, 98962 U9 modifier
 - b) CHI: G0019, G0022
 - c) (TBD) NEW dental CHW codes
2. Where will you document your CHW encounters?
3. How will you monitor your CHW documentation and service delivery?
4. What kind of support, mentoring, and training you are going to provide for your CHWs?

Five Steps to CHW Billing: STEP 5 - Billing

Think about: claims submission

1. What clearinghouse will you use?
2. Who on your team will review claims for accuracy of information and completeness before submission?
3. How will your team reconcile payments?
4. Let's discuss troubleshooting. This can be time consuming and complicated.
 - a) How will you address denials and rejections?
 - b) What is your plan to keep an eye on rejections? (Rejections do not enter into the payer's adjudication system and won't appear on EOBs.)
 - c) How will your claims workflow address timely filing?

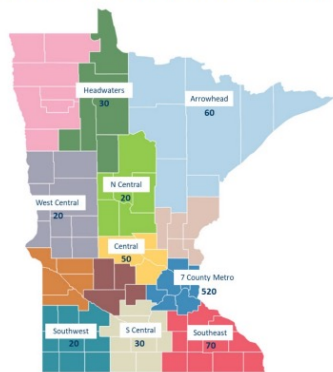

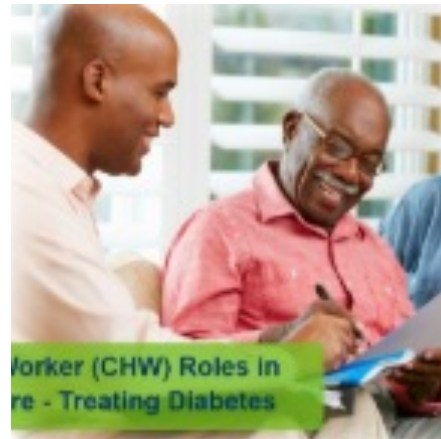
MINNESOTA COMMUNITY HEALTH WORKER INITIATIVES IN MINNESOTA

CHW Labor Estimates by Economic Development Region



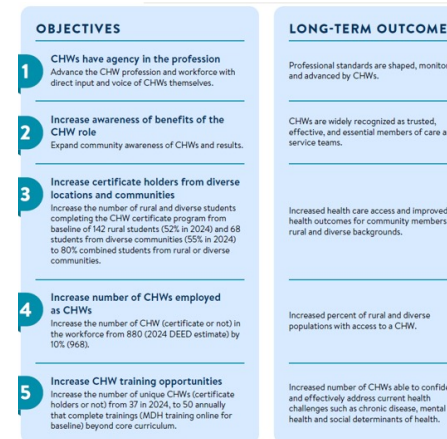
2024 MDH Environmental Scan of the CHW Field

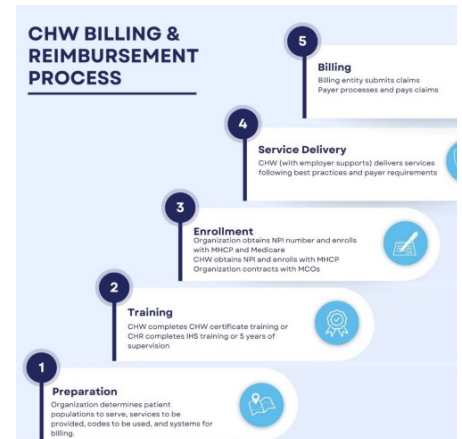
